Now Definitely, prayer/supplication stands the conversation of the Vocal Order of the presentation of articulated expressive desire before a specified authority, even the beseeching of The Authority unto the full effectual enforcement and manifestive action of its intervening ability as unto the erection and establishment of the Defined hope beseeched for by the praying party, which beseeching stands founded upon the knowledge of the Authority’s ability unto the manifestation of the beseeched hope, and the knowledge of its facilitative order and defined constitution that stands the obligation and imposition unto its manifestation and erection of the beseeched hope. Definitely, Intercession stands the conversation of the advocative fiery and fervent presentation of prayer before God Almighty as unto the benefit of another person or entity being the represented beneficiary, that the answer of the prayer and the enforced manifestation of the defined and specified beseeched hope of the supplication stand unto the Divine Advantage of the Represented Beneficiary of whom the prayer is pronounced on the behalf of, where full benefit of the answer of the prayer and beseeching stands unto the advantage only of The Represented Beneficiary without the presenter’s benefit or profit by any means. Definitely (in The Heavenly Kingdom), prayer stands the conversation of the Vocal Presentation of Hope and Desire unto Him The Sovereign YEHOVAH SABAOTH WHP SIST UPON The Throne, which hope and Desire stands pronounced in both the Revelation and understanding of The Divine Nature, Ability and Faithfulness of YAHWEH ADONAI SABBAOTH to establish the Hope, and in Reference to The Scriptural, and legal Promissory Record that stands the Obligation and Imposition upon YAHWEH SABAOTH to establish The Hope.

Thus Definitely, Prophetic Intercession in The Holy
